To assist to obtain Environmental Clearance, CRZ Clearance, Forest Clearance, Wildlife / Archaeological clearance by duly carrying out EIA Study through accredited consultants, Environmental Monitoring of various parameters, and other activities required for such statutory clearance, for various projects.
- To operate & maintain the Industrial Complexes / Parks / Growth Centres / SEZs
